



## PRIVACY POLICY FOR USERS

### 1. Identity and address of the Responsible Party.

"GIG DAO Corporation", commercially known as "Gig Marketplace", with its address at: 256 Chapman Road STE 105-4, Newark, New Castle, Z.C. 19702, is responsible for the processing and protection of your personal data in terms of this privacy notice, as well as for appointing those responsible, through the existence of a legal relationship that defines the scope of their actions.

### 2. Personal data to be processed.

For the purposes specified in this privacy notice, the responsible party collects the following data personally or indirectly from its clients when they visit the website <https://gig.io>:

- Data necessary for customer service and service provision:
- Personal identification data: first name(s) and last name(s).
- Contact information: Email address and phone number.

This data is processed under strict security measures that guarantee its confidentiality.

Under no circumstances will the responsible party collect or process sensitive personal data. If for any reason the responsible party has access to this information, it will be discarded immediately.

### 3. Purposes of personal data processing.

Primary purposes (Those that give rise to and are necessary for the existence, maintenance, and fulfillment of the legal relationship between the data owner and the responsible party):

Your personal identification and contact data will be processed for: i) your registration as a client; ii) to allow you to list, purchase, transfer or market unique digital art; iii) to inform you about changes in the service, provide critical updates, confirmations, or security alerts; iv) to evaluate the quality of the service; v) for payment of the service; vi) issuance of electronic billing related to the service and vii) to comply with legal obligations arising from the commercial relationship; viii) to provide support or respond to your comments or questions.

Secondary purposes (Those that are NOT necessary for the legal relationship between the data owner and the responsible party):

Personal identification, contact, social preferences, and interests, physical characteristics, and security and surveillance data may be used for: i) informing you about products, services, news, surveys, or promotional opportunities that we believe may interest you; ii) advertising activities; iii) analyzing and improving our platform; iv) sending promotions, newsletters or information from the responsible party's business partners and/or third parties that have a legal relationship with the responsible party; v) allowing access, control, and video surveillance/recording for the security of people visiting the responsible party's facilities and vii) evaluating the quality of the service.

In addition, your information may be used for marketing, advertising, and commercial prospecting purposes, specifically for offering and promoting goods, products, and services of the responsible party.

The owner of the personal data is informed that they have a period of 5 (five) business days to express their refusal to the processing of their personal data for all or some of the secondary purposes, without this resulting in the termination of the processing for the primary purposes, by sending an email to [admin@gig.io](mailto:admin@gig.io).

#### 4. Personal data transfers.

Pursuant to the provisions of Article 37 of the Federal Law on the Protection of Personal Data Held by Private Parties, the data controller may carry out personal data transfers when the transfer: (i) is provided for in a law or treaty to which Mexico is a party; (ii) is necessary for medical prevention or diagnosis, the provision of health care, medical treatment or the management of health services; (iii) is made to controlling, subsidiary or affiliated companies under the common control of Gig Marketplace, to a parent company or to its associates; (iv) is necessary by virtue of a contract entered into or to be entered into in the interest of the Data Subject, by Gig Marketplace and a third party or by the Data Subject and a third party; (v) is necessary or legally required for the safeguarding of a public interest, or for the procurement or administration of justice; (vi) is necessary for the recognition, exercise or defense of a right in a judicial process; and (vii) is necessary for the maintenance or fulfillment of a legal relationship between the Data Subject and Gig Marketplace. Pursuant to Article 36 of the Federal Law on the Protection of Personal Data Held by Private Parties, the data controller may carry out the following transfers of the data subject's identification and contact personal data:

Business partners of the data controller and/or third parties that have a legal relationship with the data controller, for the purpose of offering their products and/or services to them.

#### 5. Means and procedure to revoke consent and exercise ARCO Rights.

You have the right to access your personal data in the possession of the person in charge and to know the details of their treatment, as well as to rectify them in the event that your personal information is outdated, inaccurate or incomplete; cancel them when you consider that they are not being treated in accordance with the principles, duties and obligations provided by law, or oppose their treatment for specific purposes, as long as they are not necessary for the fulfillment of an obligation legal, (the "ARCO Rights").

Likewise, you may revoke the consent granted to the person in charge for the processing of your personal data as long as they are not necessary for the existence, maintenance and fulfillment of your legal relationship with the person in charge and/or security issues.

##### A. Requirements of the Request for revocation of consent and exercise of ARCO rights.

In terms of the provisions of the Federal Law on Protection of Personal Data Held by Individuals, any Request for revocation of consent and exercise of ARCO rights must contain and accompany the following:

1. Indicate the name of the owner of the data and his email to communicate the response to his request.
2. Accompany the documents that allow you to prove your identity, or where appropriate, the representation of the owner of the data.
3. Indicate a clear and precise description of the personal data with respect to which you seek to exercise your right to revoke consent or any of the ARCO Rights. If it is about rectification of personal data, you must indicate the modifications to be made and provide the documents that support your request; and
4. Indicate and/or accompany any other element or document that facilitates the location of personal data.

To exercise your right to revoke consent, as well as your ARCO rights, you may rely on the Format that is available on the website: <https://gig.io/aviso-de-privacidad> (in the Format section of ARCO request).

##### B. Means to submit requests for revocation of consent and exercise of ARCO rights.

In order for the submission of Requests for revocation of consent and exercise of ARCO rights to be simple, data subjects may submit such requests by email to [reporte@gig.io](mailto:reporte@gig.io), as long as they comply with the requirements indicated in section A above.

##### C. Term for attention to requests for revocation of consent and exercise of ARCO rights.

The receipt of a Request for revocation of consent and exercise of ARCO rights does not imply that it is declared appropriate by the person in charge. In the event that the information provided in the Request for the exercise of ARCO rights is insufficient or erroneous to attend to it, or the necessary documents are not attached to process it, the person in charge will require the owner of the data or his representative, within of the 20 business days following the receipt of the Request for the exercise of ARCO rights, for a single time, that provides the necessary elements or documents to process it. The owner of the data or his representative will have 20 business days from the day after receipt of the request, to respond.

The person in charge will respond to the Request for revocation of consent or exercise of ARCO rights with the determination reached, within a period of 20 business days from the receipt of the request, or in the event that additional information or

documents have been requested, in a period of 20 business days from the day after the response to the request is submitted, in the case of exercising ARCO rights.

If the Request for revocation of consent or exercise of ARCO rights is appropriate, the person in charge will make the determination reached effective within a period of 15 business days from the date the response is communicated to the owner of the data or the representative of he. In the case of requests for access to your personal data, the delivery thereof will be made after proving the identity of the data owner or his representative.

Responses to requests for revocation of consent or exercise of ARCO rights will be delivered to the owner of the data or his representative, by email. The information or personal data requested may be made available to the owner of the data or his representative, in an electronic file depending on the type and quantity of documents in each case.

The Personal Data Committee will be in charge of processing requests for revocation of consent and/or for the exercise of ARCO rights, as well as answering any questions you may have regarding the processing of your information, contacting said committee through the following means: i) By certified mail with acknowledgment of receipt, to the address of the person in charge; and ii) by email to the address [admin@gig.io](mailto:admin@gig.io).

## **6. Options and means to limit the use or disclosure of personal data.**

In order for you to limit the use and disclosure of your information, the following means are made available:

Your Registration in the Public Registry to Avoid Publicity (REPEP), which is in charge of the Federal Consumer Attorney's Office (PROFECO), in order not to receive advertising by telephone from providers of sectors of: i) telecommunications, ii) tourism and iii) commercial, nor that your information is used for marketing or advertising purposes.

## **7. Cookies.**

We inform you that our website uses cookies. Cookies are small files that are installed on the hard drive, with a limited duration in time that help to personalize the services. Cookies make it possible to recognize users, detect the bandwidth they have selected, identify the most outstanding information, calculate the size of the audience and measure some traffic parameters.

The personal data obtained through this technology are: i) IP address, ii) browser version, iii) operating system, iv) unique identifier. Same that we use to: i) identify the visitor's country, ii) browser language, iii) average time spent on the site, iv) number of visits per day and month, v) sections that you visit within the site, vi) which banners you click on and vii) generate analytical and statistical reports.

This technology can be disabled, depending on the browser, following the steps below:

1. Look in the browser's help section for ways to disable cookies;
2. Direct in the browser configuration tool.
